Whereas, the Department has considered the representation/documents of Shri Manzoor Ahmad Bhat, Head Assistant and during the course of examination it has been found that the promotion of incumbent was premature in pursuance of SRO 133 dated:- 09-04-1990 besides has not qualified the SAC but being a fait accompli case as he has been absorbed in Rural Development Department vide Govt Order No.233-RD&PR of 2015 dated.1-09-2015 as Head Assistant, and keeping under consideration the services of incumbent his grievance has been redressed and included in the seniority list of head Assistants at S.No. 06
