Subject: - Distribution of funds received from other departments to be spent through PRIs.

Whereas, there is a special window for Panchayats in the current year State Budget through which some devolution of funds have been envisaged;

Whereas the funds under CD Panchayat and other Centrally Sponsored Schemes are being spent under the existing norms, but there is no norm for spending the funds received from Departments like PWD, PHE etc.

Whereas it has been agreed that these funds should be spent at block level instead of panchayat level and that backward blocks should be prioritized in this regard.

Now, therefore, the following instructions are issued:

1. The funds should be first distributed district-wise on normative basis of population.
2. The Directors should specify a limited number of backward blocks, where these funds should be spent.
3. Every year these funds should be rotated so that the benefit goes to all the blocks of the district and nobody feels deprived.
4. Each block will have a specific amount of money out of which tangible assets can be created or repairs and renovations effected.
5. Before funds are released a proper plan should be prepared in consultation with the concerned department.
6. The concerned Halqa Panchayat should be entrusted with monitoring of the works executed.
