Sanction is hereby accorded to the withdrwal of funds to the tune of **Rs.2009000 (Rupees Twenty Lacs only)** from District Panchayat Officers as per the **Annexure "A" of this order** and now for its placement/release of funds to the tune of Rs. 30.00 lacs (Thirty Lacs) only in favour of the District Panchayat Officer for further placement at the disposal of Block Development Officer of his Backward Blocks (**as per Annexure "B"**) of this order under Major Head: 2702-Minor Irrigation(Halqa Panchayat) subject to the condition that:-

1. The instruction of the Finance Department as laid down in Government order No:-269-F of 2011,dated:- 23/11/2011 is adhered to strictly while releasing funds/incurred expenditure,
2. The DDO will ensure that the funds released are utilized on works in such a way that whole Irrigation runs smoothly,
3. The allotment of funds should not be construed as an authority/approval for incurring of any expenditure in violation of codal provision, financial rules and instructions issued by Government from time to time,
4. The adequate financial/technical checks are exercised with regard to quality, specification and standard of the work before entertaining the claim for payment,
5. The funds are not diverted from one unit of appropriation to another and shall not exceed under any circum stances
6. The BDO;s shall prepare proper plan/Estimate of the works in consultation with the Panchayat Raj factionaries of concerned Panchayats and get same approved by the DRDK.
7. The work identified should belong to the Department from which payment has been released. Under the estimate of work the support of line Department should be drafted.


