Sub:- Adoption of the Revised Schedule of PWD Rates, 2012 by the Department of Rural Development & Panchayati Raj.

Ref:- Recommendations of the Committee constituted vide Government Order No.214-RD&PR of 2013 dated 20.08.2013.

Government Order No. 214-RD&PR of 2014
Dated: 10-01-2014

Sanction is hereby accorded to the adoption of the Revised Schedule of Rates as notified vide Government Order No.198-PW(R&B) of 2013 dated 13.06.2013, for various works in Rural Development Department. The schedule of rates, however, shall not apply to the unskilled labour component of the works taken up under MGNREGA. The revised rates shall be adopted subject to the following conditions:-

1. That the revised schedule of rates shall be exclusive of the key material supplied by the department like steel, timber, CGI sheets, cement, fabricated steel etc. The cost of these items shall be accounted for as per the rates fixed for the departmental supplies.
2. That the rates in respect of bricks shall be fixed by the District Rate Fixation Committees headed by the District Development Commissioners of the respective districts.
3. Regarding the items for which no rates have been indicated in the Revised Schedule of Rates, 2012, the rates as fixed by the respective line departments from time to time shall apply.
4. The quality of works executed will be strictly as per the prescribed specifications.

The Revised Schedule of Rates, 2012 shall be applicable to Rural Development works with effect from 01.04.2014.
