Sanction is hereby accorded to the withdrawal of funds to the tune of **Rs.35, 00,000.00 (Rupees thirty five lakhs only)** from District Panchayat Officer **as per the Annexure "A"** of this order and now for its placement/release of funds to the tune of Rs. 52.50 lacs ( Rupees Fifty Two Lacs Fifty Thousand) in favour of District Panchayat Officers for further placement at the disposal of Block Development Officer of his Backward Blocks (**as per annexure "B"**) of this order under Major Head: 2215 Water Supply and Sanitation (Halqa Panchayat) subject to the condition that:-

1. The instruction of the Finance Department as laid down in Government order No:- 269-F of 2011,dated:-23/11/2011 is adhered to strictly while releasing Funds/incurring expenditure,
2. The DDO will ensure that the funds released are utilized on works in such a way that whole Irrigation runs smoothly,
3. The allotment of funds should not be construed as an authority/approval for incurring of any expenditure in violation of codal provision, financial rules and instructions issued by Government from time to time,
4. The adequate financial/technical checks are exercised with regard to quality, specification and standard of the work before entertaining the claim for payment,
5. The funds are not diverted from one unit of appropriation to another and shall not exceed under any circumstances
6. The BDO;s shall prepare proper plan/Estimate of the works in consultation with the Panchayat Raj functionaries of concerned Panchayats and get same approved by the DRDK.
7. The work identified should belong to the Department from which payment has been released. Under the estimate of work the support of line Department should be drafted.
