Subject:- Selection of the candidate for the post of VLW (Rural Development Department) District cadre Baramulla.

Whereas, this office has received a communication bearing No. RD/PR/Estt/NG/1/2014 dated 30-07-2015 from Administrative Department along-with order No. 325-SSB of 2015 dated 27-07-2015 issued by the Secretary J&K Service Selection Board under endorsement No. No. SSB/Secy/6760-61 dated 27-07-2015;

Whereas, pursuant to Advertisement Notice No. 04- of 2013 item No. 313 the recommendation of two candidates namely S/Shri Javid Rahim S/O Abdul Rahim (figuring at S.No 15/RBA category) and Mohd Ishaq Chohan S/O Mohd Aslam Chohan (figuring at S.No 2/Wait under ST Category) for the post of VLW Baramulla, kept withheld by SSRB for non-production of relevant documents and other testimonials, have been cancelled vide order No. 325-SSB of 2015 dated 27-07-2015 issued by the Secretary J&K Service Selection Board under endorsement No. SSB/Secy/6760-61 dated 27-07-2015, after giving them final opportunity for submitting their requisite documents;


Whereas, the Administrative Department vide their letter No. RD/PR/Estt/NG/1/2014 dated 30-07-2015 conveyed to take further course of action in matter in the light of order No. 325-SSB of 2015 dated 27-07-2015 after fulfilment of all codal formalities prescribed under rules;

Whereas, this office has to utilize two posts of VLWs one each from the waiting list of RBA and ST category. Since there is no post available from General Category of ST against which the ST candidate from waiting list can be considered, therefore only candidate from waiting list of RBA category is to be considered;

Whereas, one Shri Akhter Bashir Wali S/O Bashir Ahmad Wali R/O Tararan Tangmarg Baramulla approached to this office through an application stating therein that he is figuring at Sr. 05 in the waiting list of RBA Category recommended by the SSB under letter No. SSB/Sel/Secy/014/6697-6703 dated 04-08-2014, but Sr. No. 01 to 04 figuring in the said waiting list are presently working in Education Department as Teachers, therefore, he is the only person in the waiting list and requested for his appointment against the post of VLW caused vacant due to cancellation of the recommendation of Javid Rahim S/O Abdul Rahim R/O Bijhama Tehsil Boniyar District Baramulla figuring at Sr. No. 15 under RBA Category. The applicant has also presented an undertaking of the following candidates figuring at Sr. No. 01 to 04 in shape of Affidavit duly attested by the Sub-Judge Judicial Magistrate Baramulla, which reveals that they are working as Teachers in Education Department and are not interested to join as VLWs in Rural Development Department:-

Now therefore, before taking any decision in the matter, the above named candidates are informed through the medium of this notice to furnish their views with regard to the undertaking produced on their behalf by the applicant namely Shri Akhter Bashir Wali S/O late Bashir Ahmad Wali R/O Tararan Tangmarg Baramulla, for his appointment as VLW from the waiting list. Their views should reach this office within fifteen (15) days from the date of publication of this notice, failing which it shall be presumed that the undertaking in question is based on facts and the application of Shri Akhter Bashir Wali S/O late Bashir Ahmad Wali R/O Tararan Tangmarg Baramulla figuring at S.No 5 in the waiting list of RBA Category will be considered for appointment against the post of VLW without making any further correspondence in the matter.
