5. Sanction /approvals of competent authority be sought wherever required for before making payment.
6. The DDO will ensure that no pending arrear claims are paid out of the salary allotment without prior approval from competent authority.
7. No further release of funds shall be made unless the monthly expenditure the drawal expenditure statement is regulated by 6<sup>th</sup> of the following month in this Directorate.
