  5. The funds shall be utilized strictly as per the guidelines of the DRDA (Administration) scheme for committed component of the expenditure only and no re-appropriation /diversion is allowed at any level.
  6. The monthly progress report both physical and financial shall be submitted on regular basis to Administrative Department and Principal Accountant General for monitoring of expenditure.
  7. The genuineness of the projected budget shall be scrutinized by the Director Finance, Department of Rural Development & PR while visiting the officers of Project Officer's DRDA.


