Whereas, this office has received a selection list of candidates issued by Secretary J&K Service Selection Board Srinagar from Administrative Department vide their letter No:-RD&PR/Estt/NG/133/2016 dated:-06-10-2016, wherein recommendation of Shakeel Ahmad Lone S/O Abdul Razak Lone R/O Ajas Bandipora (figuring at S.No 04 under OM category) and Arif Nabi Najar S/O Gh. Nabi Najar R/O Sumbal Sonawari Bandipora (figuring at S. No. 01 under OSC category) were kept withheld for clarifications with regard to non-production of original DOB and PRC and valid category certificate;

Whereas, the Administrative Department vide letter No. RD&PR/Estt/NG/43/2014/AF dated 20-10-2016 has intimated that the candidates have produced the requisite documents and allied papers and released the recommendations as per the terms and conditions already conveyed under letter No. SSB/Secy/Sel/ 2016/17451-57 dated 21-06-2016;

Now therefore, in view of the above, sanction is hereby accorded to the temporary appointments of the **Shakeel Ahmad Lone S/O Abdul Razak Lone R/O Ajas Bandipora and Arif Nabi Najar S/O Gh. Nabi Najar R/O Sumbal Sonawari Bandipora** under Jammu & Kashmir Special Recruitment Rules 2015 (SRO 202 of 30th June 2015) against the post of Village Level Worker **District Cadre Bandipora** in the pay scale of Rs. 5200-20200 (Grade Pay Rs.1900) with immediate effect.

The appointees shall be on probation for a period of five years as prescribed under rules.


The candidates shall report to Project Officer Wage Employment (ACD) **Bandipora** for further postings in the district against available vacancies.

The salary of the appointees shall be drawn and disbursed to them by the concerned DDO after receipt of the verification reports relating to their qualification / Date of Birth / Character Certificate and other certificates from this Directorate.

In case the candidates were adversely reported upon by the verifying agencies viz. Board/ CID or the other relevant category issuing authority certificate is found not genuine / in-valid, they shall have no claim to hold the post to which appointed and their appointment shall automatically stand cancelled without any further notice and shall be liable for criminal proceedings.

The ACD **Bandipora** shall also take an undertaking in the form of affidavit as given in **Annexure-I** duly attested by judicial magistrate from the candidates at the time of joining.

The candidates, if fail to join within a period of 21 (twenty one) days of the issuance of this order shall forego right to their appointment which shall be cancelled forthwith.
