Pursuant to the selection and recommendation made by Service Selection Board J&K, Srinagar and received from Administrative Department vide references captioned supra, sanction is hereby accorded to the temporary appointment of **Shri. Ummer Hayat Hurra S/O Bashir Ahmad Hurra R/O Poshwari Naidkhai Sumbal District Bandipora Category (OM)** under Jammu & Kashmir Special Recruitment Rules 2015 (SRO 202 of 30th June 2015) against the post of Village Level Workers **District cadre Bandipora** in the pay scale of Rs. 5200-20200 (Grade Pay Rs.1900) with immediate effect.

The appointee shall be on probation for a period of five years as prescribed under rules.

The candidate shall report to Project Officer Wage Employment (ACD) **Bandipora** for further posting in the district against available vacancy.


The salary of the appointee shall be drawn and disbursed to him by the concerned DDO after receipt of the verification report relating to his qualification / date of birth / Character certificate and other certificates from this Directorate.


In case the candidate is adversely reported upon by the verifying agencies viz. Board / CID or the other relevant category issuing authority certificate is found not genuine / in-valid, he shall have no claim to hold the post to which appointed and his appointment shall automatically stand cancelled without any further notice and shall be liable for criminal proceedings.



The ACD **Bandipora** shall also take an undertaking in the form of affidavit as given in **Annexure-I** duly attested by judicial magistrate from the candidate at the time of joining.

If the above mentioned candidate fails to join within a period of 21 (twenty one) days of the issuance of this order shall forego right to their appointment which shall be cancelled forthwith.
