**The allotment of funds is release subject to the fulfillment of following conditions that:-**

1. Funds shall not be diverted to any other purpose and utilized strictly for which these are meant.
2. The expenditure shall be restricted to the allotment and shall be incurred after observing all codal formalities/financial rules and instruction issued from time to time by the Finance Department. The excess over the allotted funds shall in no case be entertained/tolerated.
3. Sanction/approval of competent authority be sought wherever required for before making payment.
4. The DDO will ensure that no pending arrear claims are paid out of the salary allotment without prior approval/sanction for the competent authority.
5. The utilization certificate/update expenditure be furnished immediately after the expenditure is booked I.e 6<sup>th</sup> of the following month.
6. The funds are not meant for 6<sup>th</sup> pay commission arrears.
