Sanction is hereby accorded to the release of **revalidated amount of funds** to the tune of **Rs.150.79lacs(Rupees One Crore fifty lacs seventy nine thousand )** only under 13<sup>th</sup> Finance Commission Award (13<sup>th</sup> FC) in favour of **Executive Engineer (REW)** as per **Annexure-A** to this order for **"Construction of Common Facility Centres"** for it's utilization during 2016-17 under 13<sup>th</sup> Finance Commission Award- Performance Grant.

*The funds be utilized subject to the following conditions:-*

1. The Drawing & Disbursing officer shall immediately release the funds to the executing agencies for its utilization on the object of expenditure mentioned in the 13<sup>th</sup> FC Award.
2. The Drawing & Disbursing Officer shall provide to the Administrative Department the institution wise allocation of funds out of instant release.
3. The amount of each CFC's is restricted to Rs 37.80 lacs under revised cost.
4. The Drawing & Disbursing Officer shall indicate in their sanction order component / scheme wise allocation of funds to be utilized, a copy shall be provided to this Directorate for onward transmission to the Administrative Department.
5. The Drawing & Disbursing Officer shall send a status report about the scheme, physical and financial progress, cumulative and physical achievements to the Administrative Department.
6. The financial rules/ orders by the Government/ Finance Department from time to time shall be observed while incurring expenditure against allocation.
7. Administrative Approval/ Technical Sanction where ever required should not only be sought, but be obtained before the expenditure is incurred.
8. The work shall be executed after observing all codal formalities.
9. The amount shall be debited to Account Head as detailed hereunder:-


