3. The expenditure shall be restricted to the allotment and shall be incurred after observing all codal formalities/financial rules and instruction issued from time to time by the Finance Department. The excess over the allotted funds shall in no case be entertained.
4. **The DDOs concerned shall ensure that the Honorarium/Remuneration is paid to the CIC Operators after verifying their all credentials and after fulfilling other required formalities.**

5. The DDOs in pursuance to Administrative Department's letter No.RDD/Acctts/Releases/99/2016 dated: 25.7.2016 are advised to meet out the pending due claims/liabilities of 2014-15 out of the funds allotted for 2016-17.
6. No further release of funds shall be made unless the monthly expenditure, and drawl expenditure statement is regulated by 7th or before of the following month in this Directorate.
7. That further allotment of funds will be made on production of:--
- A clearance certificate from Audit Office regarding OB item.
 - Reply of AIR's from Audit office and Directorate of Audit and Inspection Department as per format devised vide Govt. order No. 141-RD of 2011 dated;- 18.7.2011
 - QPR's and allied information.
 - Inventory of physical verification of store items
