3. The expenditure shall be restricted to the allotment and shall be incurred after observing all codal formalities/financial rules and instruction issued from time to time by the Finance Department. The excess over the allotted funds shall in no case be entertained.
4. Sanction/approval of competent authority be sought wherever required for before making payments.
5. No further release of funds shall be made unless the monthly expenditure/ drawal expenditure statement is regularly forwarded by 10<sup>th</sup> of the following month in this Directorate, for monitoring of the expenditure.
