The appointee shall be on probation for a period of five years as prescribed under rules.

The candidates shall report to Project Officer Wage Employment (ACD) **Kupwara** for further postings in the district against available vacancies.




The salary of the appointees shall be drawn and disbursed to them by the concerned DDO after receipt of the verification report relating to their qualification / date of birth / Character certificates and other certificates from this Directorate.

In case any of the candidate is adversely reported upon by the verifying agencies viz. Board/ CID or the other relevant category issuing authority certificate is found not genuine / in-valid, he/she shall have no claim to hold the post to which appointed and his/her appointment shall automatically stand cancelled without any further notice and shall be liable for criminal proceedings.

The ACD **Kupwara** shall also take an undertaking in the form of affidavit as given in **Annexure-I** duly attested by judicial magistrate from each candidate at the time of joining.

The candidates who fail to join within a period of 21 (twenty one) days of the issuance of this order shall forego right to their appointment which shall be cancelled forthwith.
