1. Leave sanctioning authority shall carefully verify the service record of the retired employee while sanctioning leave encashment/retirement benefits. The DDO shall be personally responsible for any excess payment on this account.
2. The DDO will operate funds strictly under rules. The leave sanctioning authority/DDO shall ensure that the claim of the cash in lieu is drawn on or after the date of retirement and not before the date of retirement.
3. The DDO himself will be responsible for the calculation of cash in lieu of leave salary with reference to the earned leave at credit of the retiree.
4. If there is any case against any of the retiree including in the sanction order pending in the department/vigilance department/court of Law, in such case payment shall not be release till outcome of the case/orders from this office.
5. The expenditure shall be restricted to the allotment shown above.
