
The candidates shall report to Project Officer Wage Employment (ACD) Kupwara for further postings in the district against available vacancies.

The salary of the appointees shall be drawn and disbursed to them by the concerned DDO after receipt of the verification report relating to their qualification/date of birth/Character certificates and other certificates from this Directorate.

In case the candidate is adversely reported upon by the verifying agencies viz. Board/CID or the other relevant category issuing authority certificate is found not genuine / in-valid, shall have no claim to hold the post to which appointed and his appointment shall automatically stand cancelled without any further notice and shall be liable for criminal proceedings.

The ACD, **Kupwara** shall also take an undertaking in the form of affidavit as given in **Annexure-I** duly attested by judicial magistrate from the candidate at the time of joining.

The candidate, if fail to join within a period 21 (Twenty-One) days of the issuance of this order shall forego right to his appointment which shall be cancelled forthwith.
