Dear Secretary

As you are aware, the nation will be conducting "Gram Swaraj Abhiyan" (Village Self Governance Campaign) from 14<sup>th</sup> April to 5<sup>th</sup> May 2018. This campaign aims to generate nation-wide efforts to increase social harmony across villages, foster farmer's progress, promote rural development by generating awareness about various schemes, emphasise the centrality of Gram Sabha and accountability of Gram Panchayat in implementation of these schemes and strengthen Panchayati Raj.

2. An important aspect of the campaign this year will be the public disclosure to Gram Panchayats (GPs) regarding desegregated funds and the activities to be carried out in each GP area, for each of the schemes implemented by the line departments. Photographs of Flex or Wall Paintings put up in Panchayat Bhawans would be required to be uploaded to the website designated for monitoring the Gram Swaraj Abhiyan. The number of GPs where such public disclosure was done will constitute an important parameter for the event.
