8. DDO's shall strictly inspect and supervise the public receipts and expenditure with references to the

Appropriation Act.2015 and all the standing rules and regulations.

9. All the Sanctions /approvals and clearance shall be in place before drawal of money from the Treasury.

10. The expenditure on account of Sweeping charges shall be the first charge on the release under OE component.
