- 8. All the controlling officers/DDOs shall conduct periodic reconciliation of remittances and drawls with the Treasury and Office of the Accountant General (A&E) J&K to ensure correct reflection on income and expenditure in the Finances and other Accounts.
- 9. DDO's shall strictly inspect and supervise the public receipts and expenditure with references to the Appropriation Act.2015 and all the standing rules and regulations.
- 10. All the Sanctions /approvals and clearance shall be in place before drawal of money from the Treasury.
- 11. Funds under salary/Wages/Honorarium and Remunerations for those who have been appointed by the competent authority.
