- 3. There should be uniform expenditure under each object head to avoid rush of expenditure during the last quarter of the financial year.
- 4. Treasury Officers shall not allow parking or drawal of funds in the civil Deposits without the prior concurrence of the Finance Department.
- 5. DDO's shall be duty bound to ensure submission of revenue and expenditure statements to the Administrative Department on monthly basis.
- 6. DDOs shall complete all the codal formalities before presentation of bills at the Treasury.
- 7. All the controlling officers/DDOs shall conduct periodic reconciliation of remittances and drawls with the Treasury and Office of the Accountant General (A&E) J&K to ensure correct reflection on income and expenditure in the Finances and other Accounts.
- 8. DDO's shall strictly inspect and supervise the public receipts and expenditure with references to the Appropriation Act.2015 and all the standing rules and regulations.
- 9. All the Sanctions /approvals and clearance shall be in place before drawal of money from the Treasury.
- 10. Funds under salary/Wages /Honorarium and Remunerations for those who have been appointed by the competent authority.
