
In terms of the J&K Compassionate Appointment Rules, 1994, notified vide SRO-43 dated 22-02-1994, sanction is hereby accorded to the temporary appointment of **Shri Wakar Nabi S/O Late Ghulam Nabi Dar R/O Kondabal Safapora District Ganderbal** as **Village Level Worker (VLW)** in the pay level-2 of Rs. (19900-63200) (Revised) in District Ganderbal.

The appointee shall report to Project Officer Wage Employment (ACD), Ganderbal for further posting in the District against available vacancy with in a period of 21 days from the date of issue of this order and in case, he does not join within the stipulated period, his appointment shall be deemed to have been cancelled **ab-initio** without any further notice. The Project Officer Wage Employment (ACD) shall allow the appointee to join only, on production of following documents / certificates in original to be verified subsequently:-

1. **Date of Birth Certificate.**
2. **Education Qualification Certificate.**
3. **Permanent Residence Certificate issued by competent authority.**
4. **Health Certificate issued by the Chief Medical Officer.**
5. **Dependant Certificate issued by the Assistant Commissioner Revenue.**
6. **No Loan Certificate under Self Employment scheme from DIC and concerned Employment Department.**
7. **Any other Certificate as required under rules.**

The appointee shall be initially on probation for a period of two years. In case, on verification, any of the certificates produced by the appointee is proved to be fake or forged or if the adverse report with reference to Character and Antecedents is received from Inspector General of Police (CID), the appointment shall be cancelled **ab-initio**.

The salary of the appointee shall be drawn and disbursed only after satisfactory report about the verification of his certificates is received from the concerned quarters and nothing adverse with reference to Character and Antecedents is received from the Inspector General of Police, (CID).
