- However, their appointment shall be subject to the following conditions:-
- The appointment order of such appointee shall be deemed to be cancelled, in case, at any stage, it emerges that the certificates/documents produced by the concerned are fake or forged.
 - The appointee shall give an undertaking in the shape of an affidavit to the effect that in case adverse report about his character/antecedents is received from Additional Director General of Police, CID J&K to whom a reference shall be made by the department, the appointment of the candidate shall be deemed to have been cancelled ab-initio.
 - Verification of all the certificates like Date of Birth, qualification, migration/non-Migration, from the concerned issuing authorities and verification of Permanent Residence Certificate from concerned Deputy Commissioner through Relief and Rehabilitation Commissioner (M) Jammu.
 - The salary of the appointee shall not be drawn and disbursed to him unless satisfactory report in respect of condition (b) and (c) above is received.
 - The appointee shall have to execute an agreement with the Government in terms of Jammu and Kashmir Kashmiri Migrants or Kashmiri Pandits (Special Drive) Recruitment Rules, 2009 notified vide SRO 412 Dated.30/12/2009 read with SRO 425 Dated; 10/10/2017.
 - The appointment shall also be subject to the writ petition(s), if any, pending before any court of law.
