Subject:- Final Show Cause Notice.

Whereas, you have been engaged as Programme Officer on (contractual basis) under the scheme MGNREGA vide order No. 136-RD&PR of 2013 dated 23-05-2013, on the recommendations of the Selection Committee constituted by the Government vide order No. 386-RD of 2012 dated 21-09-2012;

Whereas, Additional District Programme Coordinator (MGNREGA) Budgam, vide communication No. ACD/Bud/998-99 dated 13-02-2020, has reported that you are absconding from your legitimate duties w.e.f. 05-08-2019 and despite many reminders / notice you have failed to attend your duties till date;

Whereas, Additional District Programme Coordinator (MGNREGA) vide communication No. ACD/Bud/Estt/1429-30 dated 29-02-2020, has further reported that you have left the station un-authorizedly without submitting any leave application and have not sought any station leaving permission;

Whereas, you have been also served upon a notice by the Block Development Officer, Beerwah vide communication No. BB/Estt/204 dated 03-01-2020, to your residential address seeking the reply regarding your unauthorized absence from the legitimate duties;

Whereas, Additional District Programme Coordinator (MGNREGA) further reported that you did not bother to attend upon on the instructions embodied in the correspondence presumably by appearing in person before her office or could furnish the reply to the notices served upon and it seems that you are not interested to resume the duties and it is difficult to ascertain your actual whereabouts whether you are staying within or outside the country.



Now, therefore, before your contractual engagement as Programme Officer under the scheme (MGNREGA), is terminated, you are hereby directed to explain your position as to why the action contemplated is not taken against you. You should personally attend this office of undersigned with your reply by or before **19th of June 2020** on any working day.

In case of your failure to report to this office alongwith your explanation, it shall be presumed that you have nothing to say in your defence and your contractual engagement shall be terminated with effect from the date of your absence without further notice.
