**Whereas,** General Administration Department vide Government order No. 13-JK-GAD (Vig) of 2021 dated 22-02-2021 has accorded sanction for prosecution of accused in- service public servant namely Irshad Ahmad Lone S/O Gh Mohiuddin Lone R/O Naidkhai, Sumbal District Bandipora the then Junior Assistant BDO Office Gurez for commission of offences punishable under Section 5 (1) (c) (d) r/w 5 (2) of the Prevention of Corruption Act, Samvat 2006 and Sections 120-B, 409, 420 RPC in case FIR No. 33/2009 P/S VOK (now ACB);

**Whereas,** General Administration Department vide O.M. No. GAD(Vig)26-SP/2019 dated 22-02-2021 has requested Secretary to the Government, Department of Rural Development & Panchayati Raj J&K to:-

- i) Initiate Departmental Action (RDA) against the above named accused public servant in terms of provisions contained in Jammu & Kashmir Civil Services (Classification, Control and Appeal) Rules, 1956 and circular instructions notified vide Circular No. 49-GAD if 2018 dated 12-12-2018 r/w Circular No. 06-JK(GAD) of 2020 dated 03-02-2020.
- ii) Pending enquiry, the said accused in service public servant be placed under suspension with immediate effect.

**Whereas,** Administrative Department of Rural Development & Panchayati Raj J&K vide letter No. RDD-GAZ/32/2021 (e. office) dated. 15-03-2021 has directed that the accused in service public servant namely Irshad Ahmad Lone S/O Gh Mohiuddin Lone R/O Naidkhai, Sumbal District Bandipora the then Junior Assistant BDO Office Gurez be placed under suspension with immediate effect by Director Rural Development Kashmir (being an appointing authority) and the copy of same be submitted to Administrative Department for its onward submission to General Administration Department;



**Whereas,** as intimated by Assistant Commissioner Development Baramulla vide letter No. ACD/Bal/E-Complt/21276-79 dated 13-03-2021 Irshad Ahmad Lone S/O Gh Mohiuddin Lone R/O Naidkhai, Sumbal District Bandipora has been already placed under suspension and attached with the office of Block Development Officer Rohama by Assistant Commissioner Development Baramulla vide order No. 101-ACD of 2017 dated 21-01-2017 in connection with misappropriation of funds under 13th FCA (Panchayat Ghar) / illegal withdrawal of funds through cheques during his tenure as Junior Assistant in Block Pattan. The committee constituted by Assistant Commissioner Development Baramulla has furnished its findings and the consequent Article of charges to the said delinquent official have been served by this Directorate vide No. DRDK/E-Complt/7501-03 dated 08-06-2017. However, the reply of the accused to the Article of Charges has not been received by ACD Baramulla;

Therefore, in view of above, it is hereby ordered that Irshad Ahmad Lone S/O Gh Mohiuddin Lone R/O Naidkhai, Sumbal District Bandipora the then Junior Assistant BDO Office Gurez shall continue to remain under suspension in pursuance of Government order No. 13-JK-GAD (Vig) of 2021 dated 22-02-2021 issued by General Administration Department J&K.
