The concerned Block Development Officer shall assign charge of 2-3 contiguous Panchayat Halqas to afore mentioned appointee.


The appointment of above candidate shall be subject to following terms & conditions:-

1. The appointee shall report to concerned Block Development Officer within a period of 21 days from date of issuance of this order failing which his appointment shall be deemed to have been cancelled without any notice in terms of Circular No: 08-JK (GAD) of 2019 Dated 04.12.2019 issued by General Administration Department, J&K.
2. His appointment shall be governed by Government order No. 391-F of 2019 dated 11-07-2019 issued by Finance Department J&K.
3. The appointee at the time of joining shall produce following testimonials in original to be verified by the concerned DDO from respective issuing authorities and the salary be released only after receipt of satisfactory verification reports in this regard:-
 - i. Domicile Certificate.
 - ii. Date of Birth Certificate.
 - iii. Qualification Certificate(s).
 - iv. Category Certificate, if any.
4. The appointee shall also produce Health Certificate duly issued by concerned Chief Medical Officer.

5. That if the appointee has taken loan for self-employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counseling Centre of the Domicile District, he/she shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self-employment unit/enterprise before joining the Government service. He/she shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his/her salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self-employment unit/enterprise and recovery to be made and also personally monitor its recovery.
6. The appointee shall be imparted training in terms of Schedule-I to Government order No. 391-F of 2019 dated 11-07-2019 issued by Finance Department J&K.
7. The appointee shall be on probation for a period of two years and completion of probation period shall be subject to successful completion of training modules and passing of the related examination.
8. The cadre/transfer / performance appraisal of the above appointee shall be governed by Government order No. 373-F of 2019 dated 27-06-2019 issued by Finance Department J&K.
9. The appointment shall be deemed to be cancelled if at any stage it emerges that the certificates/testimonials produced by the candidate are fake or forged.
10. The seniority of the members of cadre shall be regulated under J&K Civil Services (Classification, Control and Appeal) Rules, 1956 and shall be fixed in accordance with the merit obtained by them in Panchayat Accounts Assistants Examination on the date of their passing.
11. The appointment will also be subject to the outcome of the writ petitions, if any are pending in any Court of Law.
