

Sir,

In fulfillment of the requirements under RGPSA and BRGF CB&T Plan 2013-14, the Institute has scheduled 11 ToT programmes on Sectorally Focused Courses for 440 Departmental Resource Persons (DRPs) from 25th of November, 2013. The details of the proposed training series are given in the enclosed Training Calendar as **Annexure-A.**

The Institute is in the process of formulating a detailed Training Module for the purpose which shall be shared with the Department well before the commencement of the series.

An aggregate Budget for the series has been worked out on the basis of the approved norms provided by the Ministry of Panchayati Raj (MOPR), Govt. of India which works out at Rs. 27. 50 lakhs. The amount works out at Rs. 6, 56,250/ for BGF and Rs. 20, 93, 750/ for non-BRGF districts. The item-wise expenditure details per course are placed at **Annexure-B.** The necessary funds may accordingly be released in favour of the Institute for smooth conduct of the series.

Moreover, instructions may be passed to the concerned Directorates to make the nominations and ensure participation of the already identified DRPs in the series as per the Training Calendar.
