



CORRIGENDUM NOTIFICATION No :- 05- -DRDK of 2018 DATED :- 15 .10.2018

To this office Notification No: - 324 DRDK of 2017 dated: - 01.03.2017 issued under endorsement No: - DRDK/Pyt/35576-35723 dated: - 01.03.2017 and Notification No: - 2 DRDK of 2018 dated: - 10.01.2018 issued under endorsement No: - DRDK/ Pyt/Res /Women / 29957-30153 dated: - 10.01.2018.


1. Whereas, the Director Rural Development Kashmir is prescribed authority for reservation and allotment of Sarpanch and Panch Seats for SC/ST/Women & ST as per Sub-section (3) of Section (4) of Jammu and Kashmir Panchayati Raj Act 1989 amended upto 2018 and Sub- Rule (1-A) of Rule (4) Panchayati Raj Rules 1996 amended upto September - 2018.
2. Whereas, this office has furnished some new proposals of Panchayats / Wards received from concerned Districts to Chief Electoral Officer J&K Srinagar vide this office letter No:-DRDK/Pyt-Elc/19899-19910 dated :- 01.08.2018 for necessary notification in this behalf.
3. Whereas, the General Administrative Department has formed a committee for analysis / scrutiny of new proposals regarding examining of issues of Rural Development / Urban Development areas for notification / de-notification and re-notification, vide Government order No: - 1210-GAD of 2018 dated: - 31.07.2018.
4. Whereas, the Administrative Department vide letter No:-RD/Panch/41/2018 dated: - 11.08.2018 and letter No: - RD/Panch/41/2018 dated:- 20.08.2018, has furnished the new proposals to the Chief Electoral Officer J&K Srinagar for issuance of necessary notification / de-notification and re-notification, in pursuance of the approval given by the standing committee in this behalf.
5. Whereas, the Chief Electoral Officer J&K Srinagar has issued notification under endorsement No :- 5402/Pyt/CEO/2018/2151dated :- 24.09.2018 and Director Rural Development Kashmir's notification No:- 2-DRDK of 2018 dated :- 14.08.2018 issued under endorsement No :- DRDK/Pyt/Elc/Gnl/23562-70 dated :- 14.08.2018 & Notification No :- 3-DRDK of 2018 dated :- 24.08.2018 issued under endorsement No :- DRDK/Pyt/Elec/Gnl/25248-55 dated :- 24.08.2018 regarding **new proposals of Panchayats / wards for notification / de-notification and re-notification** of areas falling under the jurisdiction of Rural Development Department.
6. Whereas, the Government has issued SRO vide No :- 334 dated :- 03.08.2018, regarding rationalization of **Panchayat Halqa Vijpara from CD-Block Naidkhai to CD-Block Hajin and as such Panchayat Halqa Vijpara has been excluded from CD-Block Naidkhai and included in CD-Block Hajin District Bandipora.**
7. Whereas, the District Panchayat Officer Anantnag / Kulgam and Kupwara reported to this office for issuance of corrigendum in Gazette notification dated: - 23.12.2017 in **Panchayat Halqa Kreeri (Block Shangus)/ Panchayat Halqa Nagam 1-A (Block D.K Marg) / Panchayat Halqa Cherkoote (Block Ramhal) and Panchayat Halqa Mudiyan (Block Keran).** The District Panchayat Officer Kupwara has also reported that one Panch constituency namely "PC-VII Yahama B" in Panchayat Halqa Yahama B

7. (**Block Mawar Qalamabad**) is missing in the Gazette notification dated: - 23.12.2017 and as such may be incorporated in the Gazette notification dated :- 23.12.2017. Besides the District Panchayat Officer kupwara vide his letter No: - DPO (K)/927-28 dated:- 28.09.2018 communicated to this office that the Constituency No :- PC-IX Gogal "B" in Panchayat **Halqa Gogal "B" (Block Wavoora)** may be un-reserved from ST category to General as only 18 souls are existing in the said Panchayat Halqa as per Census -2011 and as such necessary corrigendum to the earlier notification may be issued in light of the public representation received in this behalf.
8. Whereas, the issues needs rectification in the Gazette notification dated :- 23.12.2017, was examined and putforth by this office, before Chief Electoral Officer J&K Srinagar for issuance of necessary corrigendum in this behalf.
9. Whereas, the Chief Electoral Officer J&K Srinagar approved the above rectifications in the gazette notification dated: - 23.12.2017 and issued formal corrigendum vide notification issued under endorsement No: - 5402/CEO/LS/Pyt/2018/71 dated: -10.10.2018.
10. Whereas, the District Panchayat Officer Bandipora vide his letter No :-DPO/Bdpr/camp Bandipora dated :-03.10.2018 reported that the revised Panch reservation for SC/ST/Women & ST in respect of Block **Arin and Bonkoot** may kindly be considered and necessary corrigendum may be issued in this behalf. The District Panchayat Officer Bandipora has further reported that the population figures communicated earlier were reflected vice-versa in population file, which now have been rectified as per Census-2011 population figures in proper columns and as per letter No :- DPO/Bdpr/2018-19/1503 dated :- 15.10.2018 in respect of Panchayat Halqa **Ongam B** of Block **Bandipora** / Panchayat Halqa **Neeru** and **Zadigay A** of Block **Tulail** the District Panchayat Officer Bandipora reported that the Panch reservation were wrongly reflected in **I, IV & VII** wards instead of **II, V & VIII**, the same have been corrected and recommended for issuance of corrigendum.
11. Whereas, the District Panchayat Officer Anantnag vide his letter No :- DPOA/Pyt Elec/2018-19/ 2464 dated :-15.10.2018 reported that the revised Panch reservation for SC/ST/Women & ST in respect of Block **Breng, Hiller and Qazigund** may kindly be considered and necessary corrigendum may be issued in this behalf. The District Panchayat Officer Anantnag has further reported that the population figures communicated earlier were reflected vice-versa in population file in respect of Panchayat Halqa **Nussu** of Block **Qazigund**, which now have been rectified as per Census-2011 population figures in proper columns and in respect of Panchayat Halqa **Sundbrari B** of Block **Breng** and Panchayat Halqa **Manzmoh** of Block **Hiller**, the District Panchayat Officer **Anantnag** reported that the Panch reservation were wrongly reflected in **I, IV & VII** wards instead of **II, V & VIII**, the same have been corrected and recommended for issuance of corrigendum.
12. Whereas, the Government had de-notified ward No :- **VIII** of Panchayat Halqa **Shankerpora** Block **B.K Pora** District **Budgam** vide SRO 383 dated :- 07.09.2018 and as such the revised reservation for SC/ST/Women & ST (**Panch**) of Panchayat Halqa **Shankerpora** Block **B.K Pora** is issued accordingly. The District Panchayat Officer Budgam reported vide his letter No: - DPO/Budgam/res/pc dated: - 14.10.2018 that the Panch reservation for SC/ST/Women & ST in respect of Panchayat Halqa **Nagbal** Block **Khag** District **Budgam** has not been reserved till date and recommended for reservation of



Panch Ward No:- **II, V & VIII** as **General Women** and the District Panchayat Officer Budgam further recommended to incorporate the panch reservation of said Panchayat Halqa in the Government Gazette.

In view of the above, enclosed Annexures A, B, C&D are hereby approved for incorporating in the notifications mentioned herein above issued by the Director Rural Development Kashmir. The details of the same are also available on the website of this Directorate www.drkd.nic.in for the information of the general public.
