5. DDO's shall be duty bound to ensure submission of revenue and expenditure statements to the Administrative Department on monthly basis.

DDOs shall complete all the codal formalities before presentation of bills at the Treasury.

7. All the controlling officers/DDOs shall conduct periodic reconciliation of remittances and drawls with the Treasury and Office of the Accountant General (A&E) J&K to ensure correct reflection on income and expenditure in the Finances and other Accounts.

8. DDO's shall strictly inspect and supervise the public receipts and expenditure with references to the

Appropriation Act.2015 and all the standing rules and regulations.
