Ref:- Administrative Department's release order No.RDD/Accts/Releases/2017-18/1/10 dated;- 29.01.2018.

In pursuance to the Administrative Department release order No. RDD/Accts/Released/2017-18/1/10 dated;- 29.1.2018, sanction is hereby accorded to the release of **revised funds** (showing upto date allocation including previous releases) for the year 2017-18 under unit of appropriation in favour of BDO Ranshal Rural Development Kashmir for its utilization for specified services and purposes & for booking the expenditure under the classification as per Annexure enclosed with the order.

However, this authority shall be subject to the following conditions:-

1. That expenditure shall be made strictly as according to the classification under which funds have been authorized by the Administrative Department No. omission/commission or diversion shall be made under ;any pretax unless specifically and separately authorized .
2. Treasury Officers shall not entertain bills without complete classification under which funds have been placed with the Treasury.
3. There should be uniform expenditure under each object head to avoid rush of expenditure during the last quarter of the financial year.
4. Treasury Officers shall not allow parking or drawal of funds in the civil Deposits without the prior concurrence of the Finance Department.
5. DDO's shall be duty bound to ensure submission of revenue and expenditure statements to the Administrative Department on monthly basis.
6. DDOs shall complete all the codal formalities before presentation of bills at the Treasury.
7. All the controlling officers/DDOs shall conduct periodic reconciliation of remittances and drawls with the Treasury and Office of the Accountant General (A&E) J&K to ensure correct reflection on income and expenditure in the Finances and other Accounts.
8. DDO's shall strictly inspect and supervise the public receipts and expenditure with references to the Appropriation Act.2015 and all the standing rules and regulations.
9. All the Sanctions /approvals and clearance shall be in place before drawal of money from the Treasury.
- 10. The expenditure on account of Sweeping charges shall be the first charge on the release under OE component.**
11. Funds under salary/Wages /Honorarium and Remunerations for those who have been appointed by the competent authority.
