Subject: COVID-19 Management- Effective use of 'Aarogyasetu' App for breaking the chain of transmission of COVID-19.

Government Order No. 532-JK(GAD) of 2020
Dated: 06.05.2020

'Aarogyasetu' mobile App has been developed by Ministry of Electronics and Information Technology, GoI, to contain spread of COVID-19. In terms of Order No.40-3/2020-DM-I(A) dated 15.04.2020 issued by Union Home Secretary, Government of India, in his capacity as Chairperson, National Executive Committee, use of 'Aarogyasetu' is to be encouraged for all employees both private and public.

Ministry of Personnel, Public Grievances & Pensions, Department of Personnel & Training, vide OM dated 29.4.2020 has issued instructions for mandatory use of 'Aarogyasetu' App by all officers/staff on mobile phones immediately.

In view of above and to effectively contain spread of COVID-19, it is hereby ordered that all Government Officers/officials of the Union territory of Jammu and Kashmir shall mandatorily use 'Aarogyasetu' App in their mobile phones. The guidelines for use of 'Aarogyasetu' App are as under:

- (i) Before starting for office, user must review his/her status on 'Aarogyasetu' and commute only when the app shows 'safe' or 'low risk' status.
- (ii) The officers/staff are advised that in case the App shows a message that he/she has a 'moderate' or 'high risk' calculated on the basis of Bluetooth proximity ("recent contact with infected person"), he/she should not come to office and self isolate for 14 days or till the status becomes 'safe' or 'low risk'.
- (iii) All Administrative Secretaries, Head of the Departments and Head of the Offices shall ensure that above directions are strictly followed in their respective offices.
