The concerned Block Development Officer shall assign charge of 2-3 contiguous Panchayat Halqas to afore mentioned appointees.

- The appointment of above candidates shall be subject to following terms & conditions:-
1. The appointees shall report to concerned Block Development Officer within a period of 21 days from date of issuance of this order failing which their appointment shall be deemed to have been cancelled without any notice in terms of Circular No: 08-JK (GAD) of 2019 Dated 04.12.2019 issued by General Administration Department, J&K.
  2. Their appointment shall be governed by Government order No. 391-F of 2019 dated 11-07-2019 issued by Finance Department J&K.
  3. The salary of the appointees shall be drawn in terms of SRO 202 dated 30<sup>th</sup> June 2015 read with S.O. 194 dated 17<sup>th</sup> June 2020 issued by General Administration Department



- J&K. During the first period of two years, the appointees shall be entitled to minimum scale of pay along-with with grade pay applicable to the post.
4. The appointees at the time of joining shall produce following testimonials in original to be verified by the concerned DDO from respective issuing authorities and the salary be released only after receipt of satisfactory verification reports in this regard:-
    - i. Domicile Certificate.
    - ii. Date of Birth Certificate.
    - iii. Qualification Certificate(s).
    - iv. Category Certificate, if any.
  5. The appointees shall also produce NOC from Employment Department and District Industries Centre and Health Certificate duly issued by concerned Chief Medical Officer.
  6. The appointees shall be imparted training in terms of Schedule-I to Government order No. 391-F of 2019 dated 11-07-2019 issued by Finance Department J&K.
  7. The appointees shall be on probation for a period of two years and completion of probation period shall be subject to successful completion of training modules and passing of the related examination.
  8. The cadre/transfer / performance appraisal of the above appointees shall be governed by Government order No. 373-F of 2019 dated 27-06-2019 issued by Finance Department J&K.
  9. The appointment shall be deemed to be cancelled if at any stage it emerges that the certificates/testimonials produced by the candidate are fake or forged.
  10. The seniority of the members of cadre shall be regulated under J&K Civil Services (Classification, Control and Appeal) Rules, 1956 and shall be fixed in accordance with the merit obtained by them in Panchayat Accounts Assistants Examination on the date of their passing.
  11. The appointments will also be subject to the outcome of the writ petitions, if any are pending in any Court of Law.
