Pursuant to above referred to communication from Service Selection Board J&K, Jammu/Srinagar and as forwarded and communicated by the Administrative Department vide letter No.& date captioned supra, sanction is hereby accorded to the temporary appointment of the following candidate against the post of "**MPW**" District Cadre, Bandipora in the pay scale of Rs. Rs.5200-20200(Grade Pay Rs.1900) Pre-revised (revised Level 2) with immediate effect and is placed at the disposal of Project Officer Wage Employment (ACD) Bandipora for further posting in Block **Bankoot** :-

However, his appointment shall be subject to the following conditions:-

- a. The appointment order of the appointee shall be deemed to have been cancelled, in case, at any stage, it emerges that the certificates/documents produced by the concerned are fake or forged.
- b. The appointee shall give an undertaking in the shape of an affidavit to the effect that in case adverse report about his character/antecedents is received from Additional Director General of Police, CID J&K to whom a reference shall be made by the department, the appointment of the candidate shall be deemed to have been cancelled ab-initio.
- c. Verification of all the certificates like Date of Birth, qualification, migration/non-Migration, from the concerned issuing authorities and verification of Permanent Residence Certificate from concerned Deputy Commissioner through Relief and Rehabilitation Commissioner (M) Jammu.
- d. The salary of the appointee shall not be drawn and disbursed to him unless satisfactory report in respect of condition (b) and (c) above is received.
- e. The appointee shall have to execute an agreement with the Government in terms of Jammu and Kashmir Kashmiri Migrants or Kashmiri Pandits ( Special Drive ) Recruitment Rules, 2009 notified vide SRO 412 Dated.30/12/2009 read with SRO 425 Dated; 10/10/2017.
- f. The appointment shall also be subject to the writ petition(s), if any, pending before any court of law.



If the appointee fails to join within a period of 21 (Twenty-One) days from the date of issuance of this order he shall forego right to his appointment which shall be deemed to have been cancelled ab-initio without any further notice as per circular No.08-JK(GAD) of 2019 dated.04-12-2019. Also in case the appointee migrates from Kashmir Valley at any time during his service tenure, for any reason whatsoever, his appointment/service shall stand terminated without any notice by itself by the action of his migration.
