In terms of the J&K Compassionate Appointment Rules, 1994, notified vide SRO-43 dated 22-02-1994 and on the basis of documents furnished by Project Officer Wage Employment (ACD), Shopian vide above referred communications, Sanction is hereby accorded to the temporary appointment of **Miss Mehwish Sabzar D/O Sabzar Ahmad Naikoo (Deceased Plantation Watcher) R/O Nildora Tehsil Harman District Shopian** under SRO-43 of 1994 as **Orderly** in the Pay Level of **Rs. (14800-47100) SL-1 (Revised)** in **District Cadre Shopian** and her appointment is adjusted as per SRO-294 of 2005 dated 21-10-2005, under **General Category** to which the candidate belongs, as per the certificate issued by Tehsildar Harman.

The appointee shall report to Project Officer Wage Employment (ACD), Shopian for further posting in the District against identified available post of Orderly in **Block Shopian** with in a period of 21 days from the date of issuance of this order and in case, she does not join within stipulated period, her appointment shall be deemed to have been cancelled **ab-initio** without any further notice. The Project Officer Wage Employment (ACD) shall allow the appointee to join only on the production of following documents / certificates in original and after further authentication / verification of the certificates / documents from concerned issuing authorities:-

1. **Date of Birth Certificate.**
2. **Education Qualification Certificate.**
3. **Permanent Residence / Domicile Certificate issued by competent authority.**
4. **Health Certificate issued by the Chief Medical Officer.**
5. **Dependant Certificate issued by the Assistant Commissioner Revenue.**
6. **No Loan Certificate under Self Employment scheme from DIC and concerned Employment Department.**
7. **Un-employment / Un-Married Certificate issued by Tehsildar concerned.**
8. **Any other Certificate as required under rules.**

The appointee shall be initially on probation for a period of two years. In case, if on verification, any of the certificates produced by the appointee is proved to be fake or forged or if the adverse report with reference to her Character and Antecedents is received from Inspector General of Police (CID), her appointment shall be cancelled **ab-initio**.

The salary of the appointee shall be drawn and disbursed only after satisfactory report about the verification of her Qualification and other supporting documents is received from the concerned quarters and nothing adverse with reference to his Character and Antecedents is received from the Inspector General of Police, (CID).
