

2. No wages be paid to the DRW's who have attained the age of Sixty years in pursuance to this office letter No. DRDK/existing DRW/20330-20504 dated;- 22.4.2020
3. That the funds released are meant for current financial year i.e 2020-21.No wages whatsoever for the previous years be paid out of the released funds.
4. The payment be released in favour of Daily Rated Workers after ascertaining their genuineness in accordance with standing instructions/government order viz-a-viz the list of genuine DRW's submitted to this office.
5. A certificate be recorded on the wage bill that the DRW's have been paid their earned wages prior to imposition of ban on such engagement.
6. That the payment shall be made after proper screening of muster rolls by the concerned drawing and disbursing officers.
7. That funds shall be utilized strictly as per provision of Circular issued by Finance Department vide No. FD-VII-Gen (110) 2009-10-11 dated;- 29.4.2020, No. FD-VII-Gen (110) 2009-10-11 dated;- 9.7.2020 and No.FD/VII-Gen(110) 2009-10-V dated;- 04.09.2020.
8. The expenditure shall be incurred after observing all codal formalities and instructions issued from time to time by the Finance Department.
9. This will be exclusive responsibility of the DDO to check the eligibility, continuity etc of the Daily Rated Workers and all standing factors regarding the subject matter.
10. A certificate to the effect be recorded on the wage bill that the Daily Rated Workers have rendered their services continuously without any break from their initial engagement.
11. In case of death of any DRW the wages released from this Directorate should not in any case be adjusted with the wagers of other (remaining) DRW's and the matter of the deceased DRW be intimated immediately for further necessary action.
12. The number of DRWs mentioned in this allotment is an per the figures available in this Directorate and should not be treated as authentic. The concerned DDOs shall release wages only to these DRWs after updating the figures which may be less due to the death or otherwise.

While preferring claims before the Treasuries it should be ensured that the six-tier classification as required to be recorded on the bill, is depicted properly to avoid misclassification of expenditure.


